**Sub: Clarification regarding "increase of 10% seats" & "Willingness form" for Junior Colleges/Higher Secondary Schools under SAMS for the session 2017-18**

Madam/Sir,

With reference to the subject cited above, I am directed to intimate you that **increase of 10% seat over & above the sanctioned strength of Junior Colleges/Higher Secondary Schools is applicable for Rural and Tribal area excepting Government Junior Colleges. This increase will be applicable to the colleges, where seats had been completely filled-up after 2<sup>nd</sup> Phase of admission.** The increase of seats will be for the year 2017-18 Only.

The applicants, whose upper choices are not closed during 2<sup>nd</sup> phase of e-admission and still want to go up for higher preference option, need to submit **Slide-up willingness application** in any SRCs. They need not submit fresh CAF. The slide up willingness application form can be downloaded from <http://dheodisha.gov.in/SAMS/junior.aspx>.
